**SUBJECT:** Liability and Property (and Crime) Self-Insurance Coverage

#### **REQUEST:**

Request that City Council approve a resolution to authorize the City's contribution to the Michigan Municipal Risk Management Authority (MMRMA) for self-insurance (liability and property coverage) premium costs, SIR replenishing, and risk management consulting in the amount not-to-exceed \$672,970 through December 31, 2006.

## **REASON FOR PURCHASE:**

The City of Rochester Hills, since its inception, has participated in the Michigan Municipal Risk Management Authority (MMRMA). The association is organized under the laws of the State of Michigan to provide risk management consulting and self-insurance protection against loss to Michigan cities, counties, townships and special purpose governments. Participating governmental entities contribute to the insurance pool based on the value of property covered, claim experience and industry conditions.

The City's contribution for the year 2006 (policy year begins July 1) to the Michigan Municipal Risk Management Authority is estimated in the amount of \$672,970, as \$62,000 is estimated for possible additional contribution toward the self-retention fund (SIR). The City must maintain, at all times, on account with MMRMA, sufficient funds to pays its SIR obligation. SIR obligations can increase immediately after a claim/event is reported to the City.
