All property disturbed or altered, now or in the future, by reason of the construction, operation, maintenance, repair and/or replacement of the sanitary sewer shall be restored by the City to its immediately prior condition, except to the extent permanent improvements or alterations necessary to the use and exercise of easement rights granted hereunder are made.

The easement shall be irrevocable and non-exclusive, and Grantor and Grantor's successors and assigns may use and enjoy the easement area in common with the City.

Grantor expressly reserves to Grantor and Grantor's successors and assigns, so long as there is no interference with the construction, operation, maintenance, repair and/or replacement of the sanitary sewer: (a) the right of ingress and egress over, through and across the easement, and (b) the right to grant other non-exclusive eccement and rights of way coroos ever under and through the eccement percent other non-exclusive easements and rights-of-way across, over, under and through the easement parcel, with the condition that prior to such a grant written consent shall be obtained from the City.



### **RIDER**

Attached to and made part of Sanitary Sewer Easement dated the		, 2014, fron	n GOOD

In consideration for the Grantor granting to the City the easement referred to herein, the City agrees to the following:

- 1. Nothing contained in the easement referred to herein shall be construed to transfer to the City fee ownership of the land across which the easement referred to herein passes.
- 2. The City hereby accepts the conveyance of the said sanitary sewer and the facilities incidental thereto.
- 3. Grantor herein expressly reserves to itself, its grantees and assigns, the right to use the land across which the easement referred to herein passes for paved parking and any other purposes not inconsistent with this sanitary sewer easement, including without limitation, landscaping, construction of driveways, curbing, curb cuts and related improvements; provided, however, that no buildings shall be constructed upon the land across which the easement passes without the City's written consent.
- 4. The City agrees that in the event Grantor desires to have the City relocate the sanitary sewer referred to herein, the City will cooperate with Grantor in connection with the relocation of said sanitary sewer, provided the Grantor pays for the cost of said relocation; any such relocation shall be subject to any other approvals required by the City in connection with the relocation of said sanitary sewer.
- 5. The City shall notify Grantor before commencing any maintenance activity on the aforesaid sanitary sewer and facilities incidental thereto, except in the case of emergency (in which case the City shall notify Grantor as soon as possible), and the City shall coordinate such activity with Grantor.
- 6. The conveyance and easement referred to herein shall become effective upon the date an executed counterpart of this Sanitary Sewer Easement is recorded with the register of deeds of Oakland County, Michigan, and not prior thereto. If a counterpart of the Easement is not so recorded with said register of deeds by November 1, 2014, then this Sanitary Sewer Easement shall be of no force and effect. The City shall evidence its acceptance of the provisions contained in this Sanitary Sewer Easement by recording same with the register of deeds for Oakland County, Michigan.




