SUBJECT: Architectural and Engineering Services for Department of Public Services Garage

Improvements

REQUEST:

City Council is requested to authorize an increase to the blanket purchase order/contract for architectural and engineering services for improvements to the Department of Public Services Garage building that include HVAC Improvements, an analysis of the existing generator for load capacity and replacement of transfer switch, and installation of a new oil interceptor to DLZ Michigan, Inc., Waterford, Michigan in the amount of \$18,500.00 for a new not-to-exceed amount of \$153,500.00 and further authorizes the Procurement Manager to execute an amendment on behalf of the City.

REASON FOR PURCHASE:

At their August 28, 2023 meeting, City Council authorized a contract for DLZ Michigan, LLC., to perform architectural and engineering services related to several building improvements at the Department of Public Services Building. The projects at the DPS Garage are needed to improve building operations and working conditions for the employees located in this building. This project is addressing many issues occurring in the building. When the City brought this item forward to City Council, we had initially thought and had recommended we bundle the project together and take advantage of the cost savings as proposed in the agreement from DLZ in order to save costs and complete the project in a timelier manner, however as we have moved through this project and have ran into many unanticipated situations (oil interceptor was more difficult to evaluate, and additional services to camera the system were required, a load test was required for the generator, etc.) and it is going to be more advantageous to separate these projects, and due to all these conditions and circumstances the request for an increase is needed in order to complete the designs and specifications to bid the necessary repairs and improvements.
