SUBJECT: Increase to Blanket Purchase Order for Legal Advertisements

REQUEST:

City Council is requested to authorize an increase to the blanket purchase order for legal advertisements in the amount of \$9,000.00 for a new not-to-exceed amount of \$34,000.00 through October 31, 2023 to Oakland Press dba 21st Century Media – Michigan, Willoughby, OH.

REASON FOR PURCHASE:

The City's Purchasing Division issued a Request for Proposals for Legal Advertisements utilizing the MITN system. Oakland Press dba 21st Century Media – Michigan was awarded the contract as best value based on City's needs and legal obligations. The award was under the threshold for City Council approval and a blanket purchase order was issued in 2020 for an amount not to exceed \$25,000.

However, during the term, the number of legal publications has increased in volume. These increases have resulted in additional funding needed to be added to the blanket in order to pay the charges when they are billed and will require City Council approval to increase the blanket.
