**SUBJECT:** Heating and Air/Conditioning Maintenance Services

# **REQUEST:**

City Council is requested to authorize the a blanket purchase order to Johnson Controls, Inc., for the purchase of heating and air conditioning maintenance services for City Hall, Fire Station #1, DPS Garage and the Oakland County Sheriff's Sub-station, in an amount not-to-exceed \$187,130 for the renewal term to expire 4/10/2010.

# **REASON FOR PURCHASE:**

The City of Rochester Hills solicited proposals from professional heating/air conditioning (HVAC) contracting companies to perform routine and on-call maintenance and repair services at City Hall, Fire Station #1, DPS Garage and the Oakland County Sheriff's Office Substation. Johnson Controls, Inc. was awarded the contract as a result of an advertised bid for HVAC maintenance services. The bid covered a period of 4 years and this purchase order request is for the last 2 years of the award. Johnson Controls, Inc. performs various heating and air conditioning maintenance, repair and new installation service work; seasonal inspections of heating and AC equipment to insure proper operation; and other related work, as requested by the City, that requires the expertise of a licensed professional heating and cooling contractor.

HVAC equipment at City Hall, Oakland County Sheriff's Office Substation, Fire Station #1 and the old DPS Garage will require additional service over the term of the agreement as the equipment is aging or at the end of its useful lifespan. The new DPS Garage HVAC equipment will be under warranty for 2008 but will have to be added to the agreement in 2009. Cost for the Garage will be obtained in late 2008 and evaluated to determine whether an increase to the blanket purchase order will be necessary or not.

Best value and lowest cost.

### **Method of Purchase:**

Blanket Purchase Order/Contract

## **BUDGET:**

Funding for HVAC Maintenance Services will be taken from the Facilities Division for multiple years. A Budget Amendment may become necessary, depending upon the severity of unanticipated repairs and the addition of the new DPS Garage to the maintenance agreement.

Note: The blanket purchase order term is 28-months over three (3) fiscal years (January 2008 through April 2010.)
