Dear Mr. Shumejko:

As we discussed through various phone calls, the Road Commission of Oakland County (RCOC) is designing a boulevard for Crooks Road from I-75 to M-59. The City of Rochester Hills would like roadway lighting for the entire length of this newly constructed road within the City Limits from South Boulevard to M-59. The City of Rochester Hills has requested that HRC prepare a scope of work and cost to prepare the bid documents. Following is a scope of work to prepare design plans and special provisions to be included in RCOC bid documents for the length of the proposed boulevard that is located solely in the City of Rochester Hills.

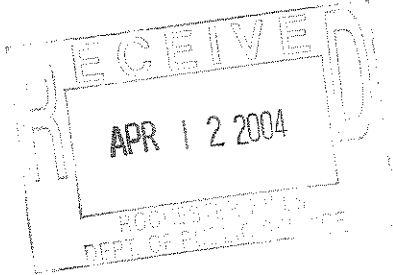
Task

1. Attend two design meetings
2. Coordinate with Detroit Edison for electrical service
3. Prepare lighting design
4. Prepare base plans utilizing the RCOC plans as the background that would be included in the RCOC bid set.
5. Prepare special provision to be added to the RCOC specifications
6. Provide RCOC with bid items and quantities to be included in the contract proposal
7. Prepare an estimate of cost for the lighting improvement

It is estimated that the fee to prepare these plans will be \$ 20,000.00. This is based on the number of hours entailed in the preparation of the plans and specifications. Our invoicing would be based on a time basis in accordance with our General Engineering Contract. The bidding date for the project was discussed and was to occur in September, 2004. We would be able to complete the plans and meet the RCOC bidding schedule.




