SUBJECT: Leach Road ROW Acquisition in conjunction with the Adams Road Relocation Project.

REQUEST:

That the Rochester Hills City Council approves the Offer to Purchase and Statement of Compensation for ROW acquisition on Leach Road in conjunction with the Adams Road Relocation Project for Bedient Land Development, LLC, a Michigan Limited Liability Company in the amount of \$8,030.00 plus closing costs.

REASON FOR PURCHASE:

Elexco Land Services, Inc. was retained by the City to acquire ROW on Leach Road in conjunction with the Adams Road Relocation Project. Bedient Land Development LLC was presented with an Offer to Purchase on August 10, 2006 in the amount of \$5,000.00. Mr. Bedient felt the offer was too low and negotiated a counter-offer based on the per square foot rate he received in 1994 from the City for other land along Leach for a sewer project. In addition, Mr. Bedient is to be compensated for two 24" diameter Maple trees that will be removed as a result of the road project.

If approved by City Council, Elexco Land Services, Inc. will begin the process of closing the transaction through Philip F. Greco Title Company.
