**SUBJECT:** Livernois Road Bridge Replacement [Non-participating cost items] – City File No. E10-023

**REQUEST:**

The Department of Public Services requests that City Council approve the attached Cost Participation Agreement between the City of Rochester Hills and the Road Commission for Oakland County (RCOC) and authorize the Mayor and Clerk to execute the agreement on behalf of the City. The agreement covers non-participating costs for the items of work proposed for construction with the Livernois Road Bridge Replacement project.

**REASON FOR PURCHASE:**

The Livernois Road Bridge replacement design included provisions for constructing several items that are outside of the eligible costs under the Michigan Local Bridge Program. The City is responsible to cover the costs associated with the non-participating items of work, which include:

- Construction of a decorative fence
- Construction of ten (10) foot wide pedestrian walk on the bridge, in lieu of eight (8) foot wide.

The estimated cost to construct the above-referenced items of work is \$27,597.00. Upon execution of the Agreement, the City of Rochester Hills will be invoiced for fifty-percent (50%) of the City's share or \$13,799. When the construction work is complete, the actual cost of the construction work will be determined and the Rochester Hills will be invoiced accordingly.

The agreement also stipulates that the City will be responsible for future maintenance of the following aesthetic amenities:

- The decorative fence
- The paint on the bridge
