REQUEST:

City Council is asked to approve the contract between the Michigan Department of Transportation (MDOT) and the City of Rochester Hills for the reconstruction and widening work along Hamlin Road from Crooks Road to Livernois Road in the estimated amount of \$1,764,000.00 and approves of any additional funds that may be owing which are identified in the final audit.

REASON FOR PURCHASE:

On December 13, 2006, the Rochester Hills City Council approved the design change from a signalized intersection to a roundabout intersection at Hamlin Road and Livernois. The design plans were modified to accommodate the roundabout. The next phase of the project was to acquire the necessary Rights-of-Way (ROW) before construction could commence. The necessary ROW was acquired and the construction funds were obligated by MDOT. The Federal funds will cover 81.85% of the approved cost expenditures for the project. The agreement details the obligations of MDOT and the City of Rochester Hills in respect to the planned improvements.
