Attached is an email correspondence that the City received regarding traffic safety concerns at the intersection of Brewster and Walton Blvd, I also included map of intersection. I spoke to resident and indicated that RCOC is working on upgrading the signal to a box-span design with the flashing yellow left-turn arrow.

I mentioned that as standard policy, RCOC no longer will consider "offset" traffic signals, similar to Adams/Powderhorn/Raintree, due to the complexity of operations and confusion to drivers. I explained the methodology for posting speed limits, 85th %, etc.

I also explained that offset intersections that are closely spaced near a signalized intersection and are problematic. I proposed that one solution may be to restrict turning movements from Cantebury or even to physically reconstruct as a right-in/right-out. In his letter, Mr. Bond requested striping a stop bar line for WB traffic prior to his sidestreet. I know that MDOT did something like this at Auburn and Barclay, but I don't think it works too well.

I indicated that we would most likely wait until after traffic signal has been upgraded prior to evaluating the intersection because the new signal will greatly modify the operations of the intersection.

Anyhow, when you have a chance can you take a look at correspondence and let me know if there are any other comments/suggestions that you would like to offer?
