SUBJECT: Purchase Authorization for One (1) Concrete Floor Saw

REQUEST:

City Council is requested to authorize the purchase of one (1) Concrete Floor Saw from Performance Line Tool Center, Waterford, MI in the amount of \$25,819.97.

REASON FOR PURCHASE:

The City issued an Invitation to Bid for the purchase of a professional concrete floor saw utilizing the MITN system. Three (3) bid responses were received. Responses were reviewed by the Department of Public Services Fleet Department. The low bid received from Malor & Company Inc. for a Husqvarna FS524 concrete saw was determined as not meeting specifications. Deviations from the specified Husqvarna FS5000D concrete saw included the FS524 model is a much smaller and lighter duty concrete saw with a gasoline engine rated at 20.8 hp, and is designed for light to medium applications. The FS5000D concrete saw, specified in the solicitation, has a diesel engine rate at 47 hp and is designed for heavy duty sawing application. The FS524 model would not meet the City's needs. The next lowest bid from Performance Line Tool Center meets all specifications.

Concrete floor saws (flat saws) are used by the Department of Public Services crews to cut asphalt and concrete for road, curb and drive repairs on major and local roads, parking lots and driveways. This new saw will replace an 11 year old saw that has become unreliable and has developed drivetrain issues.



Award is recommended to Performance Line Tool Center as the low responsive responsible vendor meeting specifications.
