SUBJECT: Purchase Authorization for Rock Salt for the 2015/2016 Winter Season

REQUEST:

City Council is requested to authorize a blanket purchase order to Detroit Salt Company LLC, Detroit, Michigan for the purchase of rock salt in the amount not-to-exceed \$ 200,000.00 through June 30, 2016.

REASON FOR PURCHASE:

Sealed bids were solicited for sodium chloride (rock salt) by the City of Farmington Hills on behalf of the Michigan Intergovernmental Trade Network (MITN) in April, 2015. As a cooperative bid 85,650 tons of salt for 35 governmental entities, include the City of Rochester Hills, was bid. The lowest, responsive, responsible bidder was Detroit Salt Company LLC at a bid price of \$56.61 per ton, if delivered before 10/1/2015 and \$57.11 per ton, if delivered on/after 10/1/2015.

Under the terms of the contract each agency guarantees ordering a minimum of 70% of the award total, but is also allowed to order up to 130% of their estimated usage each year at the price bid. Quantities were estimated at 3,000 tons and will be managed by the Department of Public Services to insure an adequate supply.
