SUPPLEMENT A ATTACHMENT TO RESTATED ARTICLES OF INCORPORATION FOR ANIMAL AID FOUNDATION

ARTICLE II

The purpose or purposes for which the Corporation is organized are:

- 1. The Corporation is organized exclusively for the purpose of receiving and administering funds for charitable, religious, scientific, literary, testing for public safety, fostering national or international amateur sports competition, or preventing emelty to children or animals within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law) (the "Code"), in particular, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Code—specifically to organizations which advance animal causes and to organizations whose purpose is to educate the public about the protection of animals—and to facility the medical care and adoption of unwanted or abused animals.
- The Corporation, including all activities incident to its purposes, shall at all times be conducted so as to be an organization described in Section 501(c)(3) of the Code. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code, (b) by a corporation contributions to

which are deductible under Section 170(c)(2) of the Code, or (c) by a nonprofit corporation organized under the laws of the State of Michigan pursuant to the provisions of Act 162, Public Acts of 1982.

- 3. No part of the assets or net earnings of the Corporation shall impre to the benefit of or be distributable to its trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.
- 4. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for political office.

ARTICLE VI

The Board of Directors of this Corporation shall consist of not less than three (3) nor more than six (6) persons, as determined from time to time by the Board of Directors

Upon the termination, dissolution or winding up of the Corporation, provision shall be made for the payment of all liabilities of the Corporation, and all assets of the Corporation shall be distributed to an organization or organizations as are organized and operated exclusively for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Code.

ARTICLE VIII

Except as otherwise provided by law, a volunteer director of the corporation is not personally liable to the corporation for monetary damages for a breach of the director's fiduciary duty.

The Corporation assumes all liability to any person other than the Corporation for all acts or omissions of a volunteer director occurring on the date of incorporation incurred in the good faith performance of his or her duties as a director other than liability for excise taxes imposed under Chapter 42 of the Internal Revenue Code and liability resulting from claims arising under state law for mismanagement of the Corporation's assets; provided, however, notwithstanding anything to the contrary herein, the Corporation shall not be considered to have released or assumed any liability to the extent such release or assumption is inconsistent with the status of the Corporation as an organization described in §501(c)(3) of the Code.
