REQUEST:

City Council is asked to approve the contract between the Michigan Department of Transportation (MDOT) and the City of Rochester Hills for the reconstruction work on the interchange of Highway M-59 with Crooks Road, including widening of the bridge which carries Crooks Road over M-59, and reconstruction of Crooks Road north and south of the bridge in the estimated amount of the City's share of \$293,050.00 and approves of any additional funds that may be owing which are identified in the final audit.

REASON FOR PURCHASE:

MDOT, in partnership with the design-build team, will be designing and constructing the M-59 and Crooks Road interchange, which includes the 4-lane bridge crossing and the addition of two (2) new loop ramps, concrete pavement reconstruction from Crooks Road south of Austin Drive to Star Barr Road, and all other related work to design and construct the project.

Dan's Excavating, Inc. was selected by MDOT as the lowest, responsive, responsible bidder in the amount of \$9,164,500.00 for the construction portion of the project. The total estimated costs are \$12,718.060.00, with the City's share being 12.5% [\$293,050.00].
