The Zoning Board of Appeals is established by Chapter 138, of the Zoning Ordinance, Article III, of the Code of Ordinances of the City of Rochester Hills. The Sign Board of Appeals is established by Chapter 134 of the Zoning Ordinance, Article II, of the Code of Ordinances of the City of Rochester Hills. The Zoning Board of Appeals/Sign Board of Appeals has authority to entertain applications, hold public hearings, grant permits and do all other acts authorized by Codified and City Zoning Ordinance.

The Zoning/Sign Board of Appeals meets the SECOND WEDNESDAY of each month at 7:00 p.m. at the City Municipal Offices.
