SUBJECT: "2012" Pavement Striping Program

REQUEST:

City Council is requested to approve the contract for the "2012" Pavement Striping Program to R.S. Contracting Inc, of Casco, Michigan in the amount of \$49,184.20 with a 5% contingency of \$2,459.21 for a total not-to-exceed amount of \$51,643.41, and authorize the Mayor to execute a contract on behalf of the City.

REASON FOR PURCHASE:

The Road Commission for Oakland County (RCOC) received bids for their 2012 County-Wide Striping Program. R.S. Contracting, Inc. was the lowest, responsive, responsible bidder per RCOC Striping bid opened February 21, 2012 and has agreed to extend the RCOC 2012 unit pricing to the City of Rochester Hills for the 2012 construction season.

The Pavement Striping Program for 2012 includes the application of sprayable thermoplastic for the City's white and yellow longitudinal lines. The benefits of using sprayable thermoplastic over waterborne paints are as follows:

- 1) Thermoplastic is a more durable product and only requires one (1) application per year versus two (2) applications for waterborne paints.
- 2) Longer life with prolonged retroreflectivity (40 mil material versus 15 mil material).
- 3) Due to sprayable thermoplastic's quick drying time, disruption to traffic is minimized since no coning off of roads is required.
- 4) Reduced potential for vehicle tracking of materials. This results in fewer or no claims due to fast dry time (product dries after marking vehicle has traveled approximately 200 feet).
