Commercial and Industrial Plan Review Services 2014-2015

REQUEST:

City Council is requested to authorize the Mayor to enter into a contract with Code Source PC, Grandville, Michigan for commercial and industrial plan review services for 2014-2015 in the amount not-to-exceed \$60,000.00through December 31, 2015.

REASON FOR PURCHASE:

Request for Proposals for Commercial and Industrial Plan Review Services were solicited in December 2013. Proposals were evaluated by Building Department staff. Code Source PC was selected based on their experience, qualifications and providing the best value for the City.

Code Source PC will be used for plan review services on as needed basis, depending on the work load.

Code Source PC is an experienced, qualified and professional firm which has provided plan review services for the City in the past. They utilize the International Code Council Construction Cost Table which is consistent with what the Building Department currently uses.

Based on the Building Department's past experience with Code Source PC, we believe they have the capability of providing professional plan review services consistent with the Building Department's current operations, and will provide the best overall value to the City.
