SUBJECT: 2009 Oakland County Household Hazardous Waste Inter-Local Agreement

REQUEST:

City Council and Mayor Barnett are being requested to enter into the 2009 Oakland County Household Hazardous Waste (No Haz) inter-local agreement between Oakland County and the city of Rochester Hills in the not to exceed blanket total of \$90,000.00.

REASON FOR PURCHASE:

In 2008, Oakland County continued its coordination and agreement with a consortium of Oakland County Communities to provide a comprehensive household hazardous waste collection program. The City of Rochester Hills has been a partner in this agreement for the past six (6) years. The No-Haz program has provided affordable and reliable access to hazardous waste collection services for the City of Rochester Hills.

In 2008 there were a total of three (3) collection events. The City of Rochester Hills continued to exceed all expected participation levels and accounted for over 30% of the total participation among the twelve participating communities. Rochester Hills had 1299 cars (representing 1770 households) participate in all the 2008 collections, collecting 161,959.32 pounds of hazardous waste of the half million pounds collection by all events. In perspective, Rochester Hills collected more total weight in 2008 than the total program had each year from 2003 to 2006 from all participating communities.
