**Ms. Bull** stated that she is a junior at Rochester Adams High School and that this is her third year serving on the RHGYC.

**Ms. Morris** and **Ms. Bull** provided the following RHGYC Bi-Annual Report to Council:

- The RHGYC started its year off with a Swearing-In Ceremony that included five new members to the RHGYC this year.
- The RHGYC assisted at the State of the City Address by directing guests to specific areas and assisted in operating the bounce houses at the event.
- City Directors, City Council and the Mayor joined the RHGYC for their Orientation at City Hall that included a luncheon and conversations with City leaders.

**Joe Snyder**, Chief Financial Officer, explained that presented before Council is the City of Rochester Hills 2023 First Quarter Budget Amendment. He noted that this Budget Amendment consists of items that were not completed in the prior year; therefore, were carried over to the current year for completion. He stated that most of the budget amendment dollars proposed to be carried over were budgeted in 2022 and were unspent and rolled into the Fund Balance at the end of 2022 and are proposed to be reallocated in 2023. He added that in total

*the budget amendments presented tonight propose to increase total revenue by \$6.2 million and increase total expenditures by \$23 million which will result in a net impact on Fund Balances of \$16.8 million.*

*He provided the following information regarding revenue:*

- \$3 million of the \$6.2 million increase is from the recognition of American Rescue Plan Act (ARPA) funding. He added that the City has received a total of \$6.2 million in ARPA funding and these funds are currently in the City's bank account earning interest. He explained that as the funds are planned to be spent, they are recognized on the City's financial statements.*
- \$660,000 from the Drinking Water Asset Management Grant. He stated that this Grant was awarded by the State of Michigan and the City plans to expend the remainder of the funds this year and request full reimbursement.*
- \$2.5 million of net transfers-in from other City funds.*

*He provided the following information regarding expenditures:*

- \$3.1 million is for operating expenditures and the vast majority of these are for carryovers that were not completed in the previous year. He added that these expenditures include professional services, studies, community promotions in the General Fund, operating equipment in the Fire Capital and Capital Improvement Funds, water meter reader equipment in the Water and Sewer Operating Fund, the Drinking Water Asset Management Consulting Services in the Water and Sewer Capital Fund, various maintenance and repair projects in the Facilities Fund and infrastructure development in the Local Development Finance Authority (LDFA) Fund.*
- \$71,000 of new operating expenditures that include five election drop boxes in the General Fund and added that these drop boxes are required per the new State Law. He stated that the addition of cemetery markers is also included in the expenditures as well as Holiday Lighting at Innovation Hills in the General Fund, memberships and dues in the Major Road Fund, fire inventory services in the Fire Operating Fund and AED cabinets in the Facilities Fund.*
- \$17.3 million in Capital Improvement Projects due to supply chain and material shortages in 2022. He stated that projects such as the Borden Park Office, Innovation Hills Playground Phase Two and the Auburn Road project between Rochester Road and Culbertson were due to material shortages. He added that some projects started in 2022 took longer than expected to complete, such as the Old Perch reconstruction project; therefore, has been requested to be carried over into 2023. He noted that \$13.8 million of the Capital Improvement Projects were projects that were begun in 2022 and not completed in 2022. He added that \$3.5 million are new Capital Improvement Projects: the Drexelgate Water Main relocation totaling \$1.6 million and the Bloomer Park parking lot reconstruction totaling \$1 million and the remainder amount is for an increase of three fire ambulances at Fire Station Five, newly anticipated Oakland/Macomb Interceptor District Sanitary Sewer Assessment, construction of Bloomer Park Cricket Pitch and the Dutton Bridge reconstruction and water main relocation.*
- \$2.5 million of transfers out that consists of funds from the ARPA Fund to the funds performing the ARPA fund work and funds from the Capital Improvement Fund to the Facilities Fund to perform the Bloomer Park parking lot rehabilitation.*

**President Deel Opened the Public Hearing at 7:19 p.m. Seeing no public comment President Deel closed the Public Hearing at 7:20 p.m.**

***President Deel*** thanked Mr. Snyder for the detailed report and stated that the City is financially on the right track.

**Joe Snyder**, Chief Financial Officer, explained that this is the request for the First Reading to update the existing City Purchasing Ordinance from a dollar limit of \$2,000 or more and to obtain a minimum of three quotes to a new dollar limit of \$5,000 or more and to obtain the minimum of three quotes. He stated that the increase would alleviate the burden on the Purchasing Division and City Staff in procuring smaller dollar purchases for goods and services, this would increase efficiency and allow the purchases of the goods and services in a timely manner. He added that it also will enable the ability to allow the Purchasing Staff and City Staff to better focus their efforts of obtaining the best value for a higher priority and higher dollar purchases citywide. He stated that over the last few years the City has transitioned from a few major million dollar projects and a few small to medium hundred thousand dollar projects to a few major million dollar projects to several small to medium hundred thousand dollar projects each year.

**President Deel** stated that inflation plays a big part in the current projects within the City and this request accounts for the inflation.

**Bill Cooke**, Assistant Fire Chief/Fire Marshall, and **Ann Echols**, Captain/Assistant Fire Marshall, were present.

**Mr. Cooke** shared that this is the First Reading for an Ordinance Amendment to request to Adopt a new Fire Prevention Code for the City of Rochester Hills. He explained that during the Fire Department's Strategic Planning Process, staff had identified an opportunity to advance in the Community Risk Reduction Division and added that the new Fire Prevention Code is a significant upgrade for the community. He noted that the 2021 International Fire Code has been reviewed and is what the Fire Department is recommending for adoption. He added that this Code is the most current model code available for the Fire Service and is a great fit for the community.

**Mr. Cooke** stated that Section 58-58, Section 307 Open Burning has been reworked to provide a document that is easy to read and understand, to define the different types of Open Burning along with the permits required for Open Burning.

**Mr. Hetrick** stated that the primary amendments include describing the types of Open Burning; however, more importantly the amendments include the type of permit required for Open Burning.

**Mr. Cooke** responded that the Open Burning permits have been in place for years; however, he felt they needed to be better defined in the Ordinance.

**Bill Cooke**, Assistant Fire Chief/Fire Marshall, and **Ann Echols**, Captain/Assistant Fire Marshall, were present.

**Mr. Cooke** explained that the Mortar Fire Permits have always been in place along with the fees in a general category of Open Burning. He stated that Open Burning includes recreational fires, preparation fires and the use of portable outdoor fire places and the 2006 Code did not clearly define these types of fires. He added that with the 2021 International Fire Code update, it was time to address the Open Burning Section in the City of Rochester Hills Code of Ordinances. He noted that typically the City will have one to two requests for a Mortar Fire Permit per year and that there are no new fees, they are just clearly defined.

**Public Comment:**

**Mr. Zendel**, 1575 Dutton, questioned whether one permit is needed for each fire or is it one permit for the entire site. He added that he does not see a valid reason to regulate something that has very few requests.

**Mr. Cooke** responded that a permit is required for a project as a whole. He added that buildings under construction are dangerous and buildings that do not have drywall or are not fully contained can result in significant fire losses. He stated that the Fire Department feels it is important to make sure people are doing things the right way to avoid potential fires.

**Joe Snyder**, Chief Financial Officer, and Detective Whitman, Oakland County Sheriff's Office (OCSO), were present.

**Mr. Snyder** explained that he had been working with Captain Yeiser on the request for ten automated license plate readers that would be placed at strategic places throughout the City. He added that the readers would be connected to the Oakland County Sheriff's Office system to allow all of the reader devices in the County to communicate together.

**President Deel** questioned whether this purchase was part of the 2023 Budget.

**Mr. Snyder** replied that this was part of the 2023 Budget.

**Public Comment:**

**Lee Zendel**, 1575 Dutton, stated that in the request it states that the Rochester Hills Oakland County Sheriff's Office has had great success utilizing these readers, he requested elaboration on this success. He questioned why Oakland County Board of Commissioners denied this request to their own Sheriff's Department. He asked what happens if two cars are along side each other, does the reader pick up both license plate numbers or just one.

**Detective Whitman** responded on behalf of the OSCO and explained that he cannot answer Mr. Zendel's question in regard to the Oakland County Board of Commissioners denying the request. He added that Captain Yeiser would be better able to answer that question. He stated that in reply to the operation of the reader cameras, each camera is designated for one direction and is responsible for two lanes. He added that the devices have the speed and clarity to capture license plates in two lanes that are heading the same direction. He noted that the successes of the readers help provide investigatory leads that without the devices the OCSO would not have. He stated for example, retail fraud is a problem that there are times the suspect is gone before the OCSO arrives onsite. He added that with a camera reader, the OCSO would have leads that they would not necessarily have otherwise. He noted that Oakland County is not the only County utilizing the readers and that the authorities will be able to know the general location of a vehicle. He expressed that the successes of the Rochester Hills Oakland County Sheriff's Office substation have been exceptional.

**Mr. Blair** stated that he wants the OCSO to have the tools needed to get their job done safely. He shared that he has concerns about the privacy of the system and requested more information on how the OCSO will use the information provided by the readers. He questioned if the OCSO takes the information received from the reader and inputs that information into a system that will provide the results, or if there is a database that collects the information of all the vehicles that have passed the reader daily that will be stored in a cloud and available to the OCSO to look through as needed. He questioned how residents will know for sure that the system will not be abused and possibly used against them from a privacy standpoint.

**Detective Whitman** explained that they are able to do a vehicle search of a specific make and model of a car that passed the reader during a specific time frame. He added that the readers are not capturing an image of the people in the

vehicle, it is specifically meant to capture license plates and vehicles. He noted that the technology is not as intrusive as people think. He stated that he has never seen the readers used in a negative way and they are not used for general surveillance.

**Mr. Blair** questioned that if there is not a specific case being investigated, could an employer go to the OCSO and get information on a specific employee going to and from work.

**Detective Whitman** responded that every system or database that the OCSO uses has a disclaimer that states 'this is for law enforcement purposes only'.

**President Deel** stated that the data from the readers are stored with a third party and inquired if a subpoena was issued to the third party for a civil court case regarding where someone was going at a specific time of the day, whether the third party would have to honor the subpoena. He stated that if the data is housed with the OCSO it could be shielded from subpoenas for various reasons, and questioned if the data is housed with a third party could the data be subject to subpoenas.

**Detective Whitman** replied that he does not have the expertise to answer that question.

**Mr. Staran** stated that the County Corporation Counsel that advises the OCSO would have a response to whether the data would be subject to subpoenas. He stated that he was concerned about the data being subject to the Freedom of Information Act (FOIA) and added that FOIA has specific exemptions in regard to pending criminal investigations. He added that there is a possibility that the data could be obtained and used by people unaffiliated with the OCSO through a FOIA request or subpoena. He suggested directing this concern to the County Corporation Counsel for a clear answer on whether the data is subject to FOIA and subpoena.

**Mr. Hetrick** stated that Detective Whitman explained that the readers would be used to accelerate the ability to catch criminals. He inquired whether the OCSO would use the readers to ticket drivers that are speeding.

**Detective Whitman** responded that Michigan Law does not allow law enforcement to use traffic cameras to issue tickets; therefore, the readers would not be used to issue speeding tickets.

**President Deel** stated that the concern is that residents do not expect these readers to be used in a non-criminal manner that could personally affect them. He added that most residents would be ok with foregoing a fraction of their security to catch a criminal in their neighborhood, but they do not expect the data to be used in matters unrelated to law enforcement. He stated that the data is not housed by the City or by Oakland County; therefore, the data is not protected as if it was housed at the OCSO.

**Mr. Blair** reiterated that the system is a database that reports can be run to search for specific information such as vehicle model and make.



**Detective Whitman** replied that the system can also alert the authorities when a specific license plate number is read and added that it allows the OCSO to know when a specific vehicle is in the community.

**Mr. Blair** responded that he loves the idea of inputting information into the system and the authorities are alerted when the suspect passes a reader. He shared that he does not love a system that a license plate number of anyone can be inputted into and the authorities can see where that vehicle has traveled for the last 30 days. He questioned whether the system brings up additional information related to the driver or is it specific to just license plate information.

**Detective Whitman** responded that as far as he is aware the system is not connected to the Secretary of State's system that would produce additional information.

**Mr. Walker** stated that this started as a pilot program in the County and that the City of Rochester Hills had four readers that allowed the authorities to track suspects throughout the County. He questioned how effective the readers will be if the pilot program was not extended in other cities throughout the County.

**Detective Whitman** responded that participation region wide is necessary to make the readers as effective as possible. He shared that the Michigan State Police have recently purchased readers to place along I-75 that will assist in eliminating car chases. He added that car chases are extremely dangerous, especially at high speeds and almost always end with severe injuries or fatalities.

**Mr. Walker** stated if the suspect chooses a path that Michigan State Police have readers on then we have the information we need without the risk of a high-speed chase. He inquired that if the suspect chooses a path without readers, how the suspect is tracked.

**Detective Whitman** responded that within the City alone, the reader should pick up the information needed. He added that without region wide participation, the readers still provide value to the City.

**Mr. Walker** questioned whether ten readers would be enough to cover the City of Rochester Hills.

**Detective Whitman** replied that ten readers would effectively cover two-way traffic in at least five major intersections in the City.

**Mr. Walker** stated that there appears to be an effective benefit to the readers and added that he believes they would be more effective if the surrounding municipalities also utilized the readers. He noted that he shares the same concerns that Mr. Blair and President Deel have expressed, but believes that there is an effective benefit to the readers.

**President Deel** questioned how long the data is retained by the third party.

**Detective Whitman** responded that he does not know for sure, but believes the data is retained for 30 days.

**Mayor Barnett** stated that the OCSO feels very strong about having these readers in the City. He added that the concerns of Council are appropriate and suggested that if Council is not comfortable making a decision on this item tonight, this item could be postponed to another City Council meeting.

**Ms. Morlan** questioned what the process is once the information is obtained from this system and how many other surrounding communities have the readers.

**Detective Whitman** replied that the process is dependent upon the situation and that there are a handful of different databases that the information can be used to search the respective database to collect more information. He stated that he is unsure of how many communities have readers; however, there are many communities that already have the readers in place.

Mayor's Office today and celebrated their great work. He added that they are headed to the Robotics State Finals and he wished them luck.

- Rochester Adams High School Varsity Cheer Team and Rochester High School Varsity Cheer Team will be heading to the State Championship this weekend.

- Rochester Community Schools is one of the largest feeder schools into Michigan State University. He stated that there is not a family that is not impacted or connected to Michigan State University. He added that the next four Fridays the City Employees will donate to the Spartan Strong Fund through casual days. He shared that 30 deputies from Rochester Hills were dispatched to East Lansing to assist with the active shooter situation. He stated that he is proud of the way the community responded to this tragedy.

**Leanne Scott**, City Clerk, and **Rochelle Lyon**, Information Systems Director, were present.

**Ms. Scott** explained that the request before Council is for approval to authorize a contract for the software maintenance design setup, implementation and training for the City's enterprise content management system. She added that this project is a city-wide project that will be rolled out in phases and every department will utilize this software. She noted that it will take a number of years to completely roll out. **Further Resolved**, that the Rochester Hills City Council hereby authorizes the award of a contract/project budget for the software, maintenance, design, setup, implementation and training for an Enterprise Content Management System to ICC Community Development Solutions, LLC., Rochester, New York in the amount not-to-exceed \$2,000,000.00 for a period of ten (10) years from the contract execution date and further authorizes the Mayor to execute a contract on behalf of the City.

**Further Resolved**, that the City's acceptance of the proposal and approval of the award of a contract shall be contingent and conditioned upon the parties' entry into and execution of a written agreement acceptable to the City.
