SUBJECT: Carpet Cleaning Services

REQUEST:

City Council is requested to authorize a contract/blanket purchase order for carpet cleaning services to Modernistic II, Plainwell, Michigan, for a total amount not-to-exceed \$90,000.00 for a three-year period.

REASON FOR PURCHASE:

The City solicits proposals for regular carpet cleaning services to maintain the cleanliness and integrity of carpeting within City-owned buildings. This practice ensures a sanitary environment for employees and residents while extending the life of the City's assets.

A Request for Proposals (RFP-RH-25-050) was solicited, and the evaluation committee reviewed and scored all proposals received. Modernistic II was selected as the best value for the City, receiving the highest score based on their extensive experience, robust capacity, and comprehensive work plan. The firm has been in business for 52 years, employs 215 full-time staff, and has over 150 IICRC-certified technicians. Their proposal confirmed their ability to perform all work with their own personnel, utilizing truck-mounted hot water extraction, and providing a guaranteed two-hour response for emergency service. Modernistic II's proposal did not include any exceptions and met all specifications and requirements as outlined in the RFP.
