Request for Acceptance of Grant - Recommendation to accept the updated terms of the U.S. Department of Transportation Federal Highway Administration Office of Safety Grant Agreement between the City of Rochester Hills and the U.S. Department of Transportation Federal Highway Administration Office of Safety Grant Agreement for the development of a Comprehensive Safety Action Plan and two (2) Supplemental Planning activities; Non-Motorized Network Gaps & Safety Study and a Neighborhood Traffic Calming Program and Policy

**Whereas**, Rochester Hills Department of Public Services prepared and submitted an application to receive a grant under the U.S. Department of Transportation Federal Highway Administration Office of Safety Grant Agreement for Safe Streets and Roads for All (SS4A) Grant and the application has been accepted;

**Now, Therefore, Be It Resolved**, that the Rochester Hills City Council accepts the updated terms of the Grant Agreement between the City and the U.S. Department of Transportation Federal Highway Administration Office of Safety Grant Agreement, Federal Award Number 693JJ32540430, for \$440,000.00 with the City providing a 20% local match requirement in the amount of \$110,000.00 for a total project cost of \$550,000.00 and expend the funds within two (2) years of the grant agreement execution.

**Be It Further Resolved**, that the Rochester Hills City Council authorizes the Mayor as the City's Recipient and further authorizes the Mayor to execute the Grant Agreement and any subsequent required documentation on behalf of the City.
