SUBJECT: Design Engineering Services for Avon Nature Area

REQUEST:

City Council is requested to authorize a contract/blanket purchase order for design engineering services related to improvements throughout the Avon Nature Area to Spalding DeDecker Associates, Rochester Hills, Michigan in the amount not-to-exceed \$56,500.00 and further authorizes the Procurement Manager to execute an agreement on behalf of the City.

REASON FOR PURCHASE:

As part of the independent Pedestrian Bridges and Structures inspections conducted in 2023, the Avon Nature Area trail, including its overlook, boardwalks, and stairs, was identified as being in poor condition and in need of repairs/replacement. Also, in accordance with the Department's current Parks & Recreation Master Plan, this project aligns with the goal of increasing access to natural resource-based recreation.

Staff recommends proceeding with design work and obtaining permitting services from the Department of Environment, Great Lakes, and Energy (EGLE) for improvements to the Avon Nature Area trail. The proposed design would replace the existing wood infrastructure with new timbers and enhance the overall accessibility of the walking trails for public use. Spalding DeDecker is one of the City's selected on-call professional engineering firms and is being recommended to complete the required services based on their capacity, experience and familiarity with the City's parks based on work done in previous parks related projects.
