SUBJECT: On-Call Electrical Services

REQUEST:

City Council is requested to authorize a contract/blanket purchase order to Allied Building Service of Detroit, Inc, as primary vendor and K&S Ventures Inc. of Rochester Hills, Michigan as secondary vendor for On-Call Electrical Services for the City owned buildings in the amount not-to-exceed \$90,000.00 for a two-year term to expire October 31, 2026.

REASON FOR PURCHASE:

The City of Rochester Hills owns several buildings throughout the City that require routine maintenance and repairs of the electrical systems to be performed by certified electricians.

The City of Rochester Hills Purchasing Division solicited proposals utilizing the MITN system from professional electrical companies to provide on-call maintenance and repair services at city buildings. Five proposal responses were received and evaluated by a committee consisting of staff from Facilities and Purchasing departments. The proposal submitted by Allied Building Service of Detroit, Inc. was determined to be the best value proposed for On-Call Electrical Services for the City based on the evaluation criteria. The City, as part of the solicitation requirements, also included the need for a secondary vendor as a backup for emergencies, in case for any reason the primary vendor may be unavailable or unable to respond in a timely manner when needed. It is recommended to award K&S Ventures, Inc. as a secondary vendor for On-Call Electrical Services.
