## NOTICE OF PUBLIC HEARING REGULAR ZONING BOARD OF APPEALS MEETING

## TO ROCHESTER HILLS RESIDENTS:

**NOTICE IS HEREBY GIVEN THAT THE CITY OF ROCHESTER HILLS ZONING BOARD OF APPEALS** will hold a Public Hearing on August 13, 2025 at 7:00 p.m. to consider the following request:

**LOCATION:** 1141 Cripple Creek Ln., located west of N. Livernois between Tienken and Dutton Rd., Parcel 15-04-252-002, zoned RE Residential Estate.

**REQUEST:** PVAI2025-0003 – The applicant is requesting a variance from Sec. 138-5.100 Schedule of Regulations, which notes that the required side setback for a principal structure in the RE One Family Zoning District is 15 feet. The proposed variance, if granted would allow for an encroachment of 5.2 feet into the required side setback (west side of property) for

the construction of an attached garage to the existing residence.
