## **REQUEST:**

City Council is requested to authorize the purchase of picnic tables for City parks to Superior Recreation Products of Carrolton, Georgia in the amount of \$263,690 and Go Outdoors Amenities of West Melbourne, Florida in the amount of \$10,760 for a total purchase amount not to exceed \$274,450.

## **REASON FOR PURCHASE:**

The City issued an Invitation to Bid for three different types of picnic tables (6-foot, 8-foot Universal Access, and Hexagon) utilizing the MITN system. The solicitation was sent to over 200 vendors. Twenty-three (23) bids were received. Upon evaluation, eighteen (18) of the bids were determined to be non-responsive due to various reasons including unsigned bids, unacceptable products (exceeded maximum weight, exceeded maximum size, etc..) or were not in the competitive range. Of the remaining five (5) bids that were deemed to be both responsive and responsible, the award of each table type is to the low bid. Superior Recreation Products of Carrolton, Georgia is recommended for providing the low bid for both a quantity of 224 6-foot tables at \$1,110 each and a quantity of 14 Hexagon tables at \$1,075 each; while Go Outdoors Amenities of West Melbourne, Florida is recommended for award of a quantity of eight 8-foot Universal Access tables as the low bidder.

This purchase would replace the old, rustic, and wooden picnic tables throughout the Parks system with new, modern, and recycled plastic picnic tables. Tables that will be more durable and require less staff time and financial resources to maintain. They will also improve the overall aesthetics and contribute to the goal of creating a consistent look throughout the Parks system.
