NOTICE OF PUBLIC HEARING REGULAR ZONING BOARD OF APPEALS MEETING

TO ROCHESTER HILLS RESIDENTS:

NOTICE IS HEREBY GIVEN THAT THE CITY OF ROCHESTER HILLS ZONING BOARD OF APPEALS will hold a Public Hearing on July 9, 2025 at 7:00 p.m. to consider the following request:

LOCATION: 466 Driftwood Ave., located south of Bloomer Rd. and west of John R, Parcel 15-14-430-008, zoned R-3 One Family Residential.

REQUEST: PVAI2025-0005 – The applicant is requesting an <u>appeal</u> of the decision to deny a land division application for the subject property, the denial of which was partially based upon the proposed lots not meeting the minimum required width of 90 feet in the R-3 One Family Residential Zoning District per Sec. 138-5.100 Schedule of Regulations.

In addition to the appeal, the applicant is requesting a <u>dimensional variance</u> from Sec. 138-5.100 Schedule of Regulations, which requires a minimum lot width of 90 feet in the R-3 One Family Residential Zoning District. The proposed variance, if granted, would potentially allow for the division of the existing parcel into two separate parcels, each with a lot width of 80 feet.
