SUBJECT: Preliminary Professional Engineering for Study and Design of RC-01 Improvement Project

REQUEST:

City Council is requested to authorize a blanket purchase order/contract for preliminary engineering services for the study and design related to RC-01 Improvement project to Hubbell, Roth & Clark, Inc., Bloomfield Hills, Michigan in the amount not-to-exceed \$54,100.00 and further authorized the Procurement Manager to execute an agreement on behalf of the City.

REASON FOR PURCHASE:

The existing valves, piping and Pressure Reducing Valves (PRVs) within the underground vault at RC-01 were constructed in the early 1970s and are nearing the end of their useful life. Approval is requested for preliminary engineering and design services to replace the outdated equipment, right-size the PRVs based on current and future capacity needs, and design a necessary utility chase to allow for the removal and replacement of large components.

A key benefit of proceeding now is the ability to coordinate City improvements with the planned GLWA meter replacement program at RC-01. This coordination will allow for shared system shutdowns, optimizing efficiency and potentially reducing overall project costs. The City is recommending HRC, one of the City's on-call engineering firms, to perform the required services due to their extensive history and familiarity with both our water system and coordination requirements with GLWA.
