**SUBJECT:** Increase to Blanket Purchase Order for Turnout Gear, Pants, Boots

#### **REQUEST:**

City Council is requested to authorize an increase to the blanket purchase order for Turnout Gear, Pants, and Boots in the amount of \$5,500.00 for a new not-to-exceed amount of \$30,500.00 to MacQueen, St. Paul, Minnesota.

## **REASON FOR PURCHASE:**

The Fire Department previously received approval for a one-year blanket purchase order in the amount of \$25,000.00 to outfit new firefighters and replace existing required gear as needed. This blanket purchase order covers essential turnout gear, including pants and boots.

Recently, replacement firefighter boots were needed. Upon invoicing, it was determined that the current blanket purchase order did not have sufficient remaining funds to cover the cost of these necessary boots. To address this shortfall and ensure the continuous outfitting of our firefighters with essential gear, the Fire Department requested an additional \$5,500.00 be added to the blanket. This increase will allow for the complete payment of the invoice, along with any other turnout gear needed.
