REQUEST:

City Council is requested to authorize a blanket purchase order/contract for preliminary engineering services for the study and design related to Pressure Reducing Valve (PRV) 6,7,8 Improvement project to Hubbell, Roth & Clark, Inc., Bloomfield Hills, Michigan in the amount not-to-exceed \$136,900.00 and further authorized the Procurement Manager to execute an agreement on behalf of the City.

REASON FOR PURCHASE:

This project is part of a critical effort to implement recommendations made to improve water pressure for residents in specific areas of the City served by these PRV's. Preliminary Engineering Services will be provided to study and design the relocation of PRV 6 and PRV 7 to new underground facilities and an upgrade to PRV 8, along with some other system adjustments.

HRC as one of the City's on-call engineering firms, is recommended to provide the requested services based on their familiarity with our water system and understanding of the overall improvements and goals the City is trying to meet with these projects.
