#### **COUNCIL AND YOUTH COMMITTEE REPORTS**

**Rochester Hills Government Youth Council (RHGYC):**

*President Deel introduced the RHGYC Representative, Aryan Sinha.*

**Mr. Sinha** stated that he is a senior at Rochester High School and that this is his third year on the Youth Council, and he also serves on the Liquor License Committee. He expressed his excitement to continue learning about how the City government, citizens, and students can work together to grow and strengthen the community. He shared that the Youth Council has worked diligently this past month to plan their annual Cultural Fair to recognize the City's diversity. He detailed that at their last meeting, they discussed ideas to involve community members alongside free food from different cultures. He invited the public to attend the event, which will take place on April 26th from 12:00 to 3:00 p.m. in Garth Pleasant Arena at Rochester Christian University. He added that the Youth Council will participate in the Clinton River Watershed Cleanup during the week of Earth Day.

**Rochester Area Youth Assistance (RAYA):**

**Ms. Mungoli** shared that last week, RAYA held their annual Youth Recognition Banquet, where they recognized about 20 students. She noted that several Council members were present, and voiced her appreciation for RAYA to be able to recognize the young people in the community.

**Deer Management Advisory Committee (DMAC):**

**Ms. Mungoli** announced that the DMAC's biannual Deer Gardening Seminar will take place on Wednesday, March 26th, in the City Hall Auditorium. She explained that the event is being held in conjunction with the City and Bordine's, and attendees will learn how to live in harmony with deer. She noted that those wishing to attend must sign up on the City's website.

**Ms. Mungoli** also shared information about the Louise Saks Parliamentary Unit Virtual Community Workshop entitled 'I Wish I Knew: How to Make Things Happen in a Meeting,' a free, virtual-only event on Saturday, March 29th, in celebration of the upcoming Parliamentary Month. She explained that the event features not only a presentation but a panel of local parliamentarians, and noted that the QR code displayed can be used to sign up.

**Advisory Traffic and Safety Board:**

**Mr. Blair** reported that many stop signs will be installed in the South Brooklands area to slow traffic and improve safety. He noted that if anyone is concerned about speed limits, stop signs, or the timing of signals in their neighborhood, they can reach out to the Advisory Traffic and Safety Board, which meets on the second Tuesday of each month. He added that relevant information is on [rochesterhills.org](http://rochesterhills.org).

**President Deel** pointed out that the South Brooklands is a prime example of citizens presenting their concern to the Advisory Traffic and Safety Board, who then conducted a traffic study in the neighborhood.

## LEGISLATIVE & ADMINISTRATIVE COMMENTS

*Mayor Barnett provided the following updates:*

- *He shared a Sports Illustrated article calling attention to the mecca of girls' cheerleading that is Rochester Hills. He highlighted that the three high schools in the City, Rochester, Rochester Adams, and Stoney Creek, have each won three state championships since 2016, and there have been nine years since 2016, including the past two years, in which they have placed one-two-three at the state championships. He expressed the pride in receiving this national attention, and congratulated the teams.*
- *He recognized the City's crossing guard team, showing a picture from their recent Appreciation Breakfast. He acknowledged that crossing guards get up early and work in any kind of weather, and stated that without them, the City would face significant challenge. He took the opportunity to encourage people to consider joining the team if they have some extra time and want to make a little extra money.*
- *He continued with the good news that all of the City's gravel roads have now been treated, a feat that Bill Fritz, Public Services Director, and his team have been working tirelessly to accomplish.*
- *He provided the reminder that Yard Waste Pickup starts the week of March 24th with the City's partners at Priority. He directed people to the website should they have any questions or issues.*
- *He shared that the City continues to have a significant demand for lifeguards and summer staff, recalling that a shortage of lifeguards last summer forced Spencer Beach to close temporarily. He explained that many of the individuals who fill these positions are college-aged or older high school students, and shared that the website lists the available seasonal jobs, which include park attendants, lifeguards, fire hydrant painters, laborers, and groundskeepers.*
- *He promoted the Free Street Tree Program, which will open on the 23rd. He noted that trees will be distributed on a first-come, first-served basis, and people can apply through the portal on the City's website, after which the City will confirm that the tree will be planted on City property.*

**President Deel** disqualified himself from this discussion, as he serves on the Arcadia Park Board of Directors.

**Lisa Grems**, Arcadia Park Homeowners Association Director, stated that the Association is seeking the Council's approval of a five-year resolution to allow them to apply to the Michigan Department of Natural Resources for permits for the Canada goose, egg, and nest destruction. She explained that these birds are a nuisance and a health risk to residents around the two ponds in the subdivision and to motorists and pedestrians on the nearby streets. She also shared that the MDNR requires 70% of signatures from homeowners or to obtain a resolution from the City, but with 181 homes in the subdivision, receiving that many signatures is impractical. She added that as far as she is aware, this is the third time the Association has asked the Council for permission for this resolution, each lasting a five-year term.

**Mayor Barnett** acknowledged Ms. Grems as a longtime Board member of the Neighborhood Association, thanking her for her service.

*Brooke Insana, Human Resources Director, shared that the City currently contracts with Keller Thoma, P.C., for Labor and Employment legal services; however, Keller Thoma will be undergoing organizational structural changes and will be moving away from providing Labor and Employment legal services. She explained that to ensure continuity of services, Keller Thoma has recommended that the City sign its agreement with Schultz and Young, P.C., effective May 1st, 2025. Attorneys Gregg Schultz and Beth Young, who have been providing Labor and Employment services to the City, will be continuing these through their own firm, Schultz and Young, P.C. She continued that the City has been highly satisfied with the representation provided by Mr. Schultz and Ms. Young over the years, as they have been consistent with legal advice and strategically aligned with the City's vision and values, and have demonstrated fiscal constraint. She added that funding for this is included in the fiscal year 2025 adopted budget and the fiscal year*
