Hampton Circle Transportation Alternatives Program (TAP) Grant

REQUEST:

City Council is requested to authorize a contract/blanket purchase order for professional engineering design services for the completion of a Transportation Alternatives Program (TAP) grant application to OHM Advisors, Auburn Hills, Michigan in the amount not-to-exceed \$7,000.00 and further authorizes the Procurement Manager to execute an agreement on behalf of the City.

REASON FOR PURCHASE:

OHM is one of the City's selected on-call professional engineering firms and is being recommended to perform professional engineering design services for the required grant assistance services for this project based on their completion of a Lane Use Traffic Study for Hampton Circle. The study was initiated in January of 2024 and evaluated options to incorporate accessibility for vehicles, bicyclists, and pedestrians along Hampton Circle.

With the completion of the Lane Use Traffic Study, the City now seeks to apply for a TAP grant to fund improvements along Hampton Circle. OHM is being engaged to assist with the preparation of the online application, required exhibits, and updated cost estimates, along with a pre-application meeting with the city, coordination of a public input process, and a competitiveness analysis for the grant.

This proposal is for the grant application services only and does not include formal engineering design plans, permitting, or additional traffic studies. The application is based on the recommended concept from the Hampton Circle Study. Approval of this agreement will allow the City to leverage the previous study's findings to secure federal funding for the Hampton Circle project, moving it closer to the construction phase currently scheduled in the Capital Improvement Plan (CIP) for 2027.
