Whereas, the City of Rochester Hills City Council has worked to develop City Goals for the Fiscal Year 2026;
and

Whereas, based on those City Goals, the Fiscal Year 2026 Proposed Budget and the Fiscal Year 2027-28
Projected Budget was developed; and

Whereas, per City Charter, at the August 11, 2025 City Council Meeting, the Mayor delivered the Fiscal Year
2026 Proposed Budget and the Fiscal Year 2027-28 Projected Budget Plan beginning January 1, 2026; and

Whereas, at the August 11, 2025 City Council Meeting, the City Council set the Budget Public Hearing date for
September 8, 2025.
