#### **REQUEST:**

City Council is requested to authorize the purchase of one (1) Trackless Municipal Tractor MT7 and attachments in the amount of \$217,696.00 from MacQueen Equipment, LLC DBA Bell Equipment, Lake Orion, Michigan utilizing the State of Michigan MiDeal Extended Purchasing Program.

### **REASON FOR PURCHASE:**

By utilizing the State of Michigan contract for construction equipment, the City secures a competitive price for the Trackless municipal tractor and its attachments which ensures the purchase through this cooperative program provides the best value to the City.

The municipal tractor will be used for sweeping operations in the summer, trimming back over growth along roads and pathways, and snow clearing in the winter. It is especially useful for the Auburn Road corridor and clearing pathways where this machine saves time, damage to our pickup trucks, offers safer operating conditions, and better visibility for our operators. These machines are built specifically for the challenges of this type of work. We have had a previous generation Trackless that has proven to be very rugged and reliable.
