## STAFF REPORT

*Matt Einheuser discussed that in November and December, staff has been working with our stewardship contractor to complete forestry mowing and removal of brush piles from past efforts on some of our Green Spaces, such as Harding and Clear Creek. In addition, they completed stump treatments at Childress Green Space to remove woody invasives. The rest of December will include some further cutting of woody invasives at Clear Creek and Ruby. Discussion ensued.*

*Einheuser explained that the contractor, L. D'Agostini and Sons, has begun mobilizing and the streambank project is underway at Eagles Landing. HRC is doing daily construction oversight throughout the project. Discussion ensued.*

*Einheuser informed members that Staff met with the Great Lakes Fisheries Commission and other partners regarding the Clinton River cutoff restoration project to fix the river where it has bypassed the dam at Yates. This project will likely be completed in 2026 and is funded by the GLFC and USFWS.*

*Einheuser explained that Staff met with Stantec to develop 2026 priorities and projects. Our January Meeting will include an annual report from Stantec 2025 efforts and monitoring. In addition, we will go over our preliminary project schedule and budget for 2026.*

*Einheuser also mentioned that Staff is working with the National Fish and Wildlife Foundation to add additional acres to our invasive Species grant that can be included in future years treatments.*

Einheuser explained that due to the wetland, there is no way to make a connection to Auburn without a boardwalk type feature, as was initially discussed when evaluating the property and whether or not to pursue it. Overall, members expressed support for evaluating the design and implementation of a boardwalk at the Auburn location. Discussion ensued.*

*Einheuser updated members on the Bee Property which include plans for establishing a trailhead, parking area, and a pollinator garden.*
