Hi Marvie:

Per Dave Mingle's request, please see the following details regarding the design of our new stormwater management system at Auburn Oaks; the plans and calculations have been designed and reviewed by our Michigan-licensed professional engineers, and the City engineers have also approved the design of the system:

1. **Grading.** Presently, the entire property drains from north to south. Within the property, there is a low point near the middle of the site, then in the southern 1/3 the property rises a couple of feet again before dropping down to its lowest point at the southern end of the property. There is 30 feet of elevation change from the northwest corner of the property to this low point in the middle of the site. This low point has no outlet, so the water draining into this area has nowhere to go and that is why some wetlands presently exist here. On the site plan, this low area is where the single-family homes will be built; the condominium buildings are located above the area on the hillside in the northern end of the property and would not be subject to any drainage concerns (water flows downhill). To deal with potential drainage issues in the middle of the site, we are raising the low point so that the finish grades around these homes and on the road are 6-8 feet above the existing grade in this area. Grading around each building and lot are designed to drain rainwater away from buildings to nearby drainage structures.
2. **Drainage Structures and Pipes.** Drainage structures (catch basins or "yard drains") and storm sewer pipes will be installed around each building and lot. The drainage structures and pipes are designed to handle the volume of drainage that would be generated by a large storm (to prevent backup), and allow stormwater to drain into the detention basin that will be excavated in the southwest corner of the property adjacent to the lowest point on the property at its southern end. See attached grading plans.
3. **Detention Basin.** The elevation at the top of the detention basin is approximately 4 feet below the finish grades around the single-family homes. This basin has been designed to meet current City of Rochester Hills and Oakland County Water Resources Commission stormwater management standards. The current standards require the basin meet three separate tests to assure no flooding downstream or upstream and

is sized to hold a storm of duration and intensity that happens on the average of once every 100 years (a big storm also known as a 100-year flood storm event). An additional safety factor is that the basin requires an additional 1 foot of depth ABOVE the high water level that would occur during a 100-year storm. This additional 1 foot of depth is known as the "freeboard." In the event of a larger storm, any overflow from that basin would enter the freeboard first and then drain to the south offsite and not onto any onsite buildings.

4. **Groundwater.** On the northern half of the site, the permanent groundwater level is well below the basement level of all structures. In the southern end of the site, the permanent groundwater level is about 4 ½ feet below ground level. With the 6-8 feet of additional fill, that groundwater level will be 10-12 feet below the finish grade of the site. Basement slab elevations of the single-family homes will be 2-4 feet above the permanent groundwater level.
5. **Offsite Water Management.** There are no running surface water bodies (streams and rivers) within ½ mile of the site. See attached FEMA Firm map. The existing grades of the site are well above the nearest 100-year floodplain elevation (water won't rise above that level during a 100-year flood) and the final grades of the site are more than 10 feet above that nearest 100-year floodplain elevation. As a result, there is virtually no risk of flooding from offsite sources.

In summary, we worked very closely with our engineers and the City's engineers to design a robust stormwater management system at Auburn Oaks that is aligned with local regulations and best practices because stormwater management in our neighborhoods is always a high priority for us and our customers.

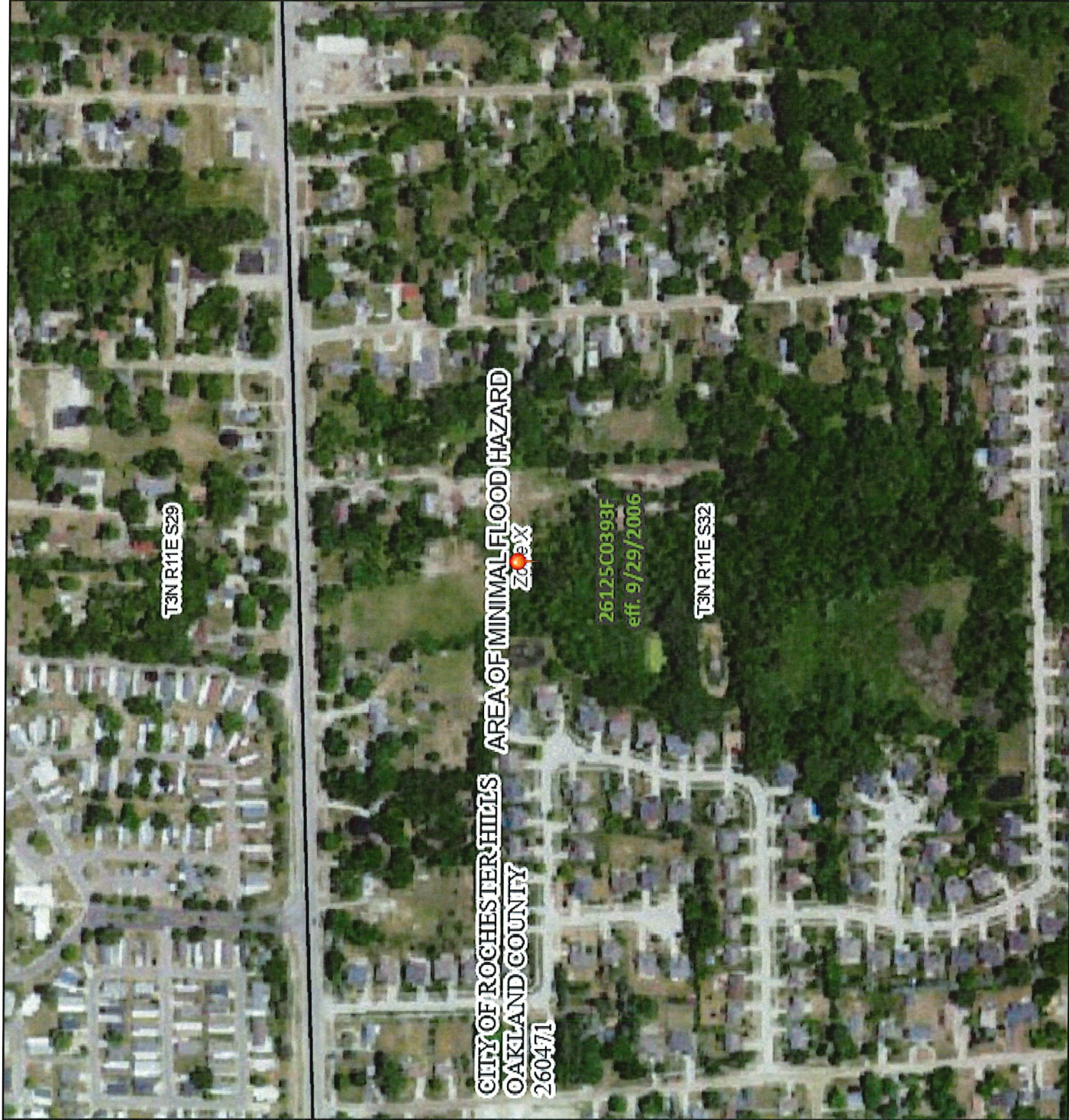
