SUBJECT: School Resource Officer (SRO) Interlocal Agreement: Avondale School District

### **REQUEST:**

We request that City Council authorize the Mayor to execute a School Resource Officer (SRO) Agreement between Oakland County, Oakland County Sheriff's Office (OCSO), Avondale School District, and the City of Rochester Hills for FY 2025-2027.

### **REASON FOR PURCHASE:**

Oakland County has requested the City of Rochester Hills sign an updated School Resource Officer (SRO) Agreement for the Avondale School District outlining the General Roles and Responsibilities of the Parties, Hours and Policy Matters, Records and Information Sharing, SRO Training Requirement and Funding Obligation, Points of Contact, Special Events, and Liability.

Of particular note in this updated SRO Agreement:

### Per Section 3(B):

Public Body (the City of Rochester Hills), as part of the consideration for the value it receives for the Services provided under this Agreement, will pay \$1 per student (not to exceed a total of \$5,000), per calendar year, to be applied to Oakland County's Safer Communities Fund, which will be used in accordance with the public purpose of that fund.

#### Per Section 3(C):

If Public Body (the City of Rochester Hills) requires the School to pay for or reimburse the Public Body for paying for the Services and other costs described in this SRO Agreement, Public Body (the City of Rochester Hills) is solely responsible for contracting with and collecting payment from the School.

## **BUDGET:**

No funding is included in the FY 2025 Adopted Budget or the FY 2026-27 Projected Budgets for this \$1 per student fee.

There are an estimated 960 total students between Deerfield Elementary and Avondale Middle School.

If approved by City Council, a FY 2025 1<sup>st</sup> Quarter Budget Amendment will be presented to increase the Contractual Police Services expenditure account by \$960 for the City to pay the \$1 per student fee to the Oakland County Safer Communities Fund. As well, if approved by City Council, the City will in turn invoice the Avondale School District for the final total and receive the total fee paid back as a reimbursement.
