SUBJECT: Public Safety, Emergency Preparedness, Safety Equipment, Solutions and Related Services

REQUEST:

City Council is requested to authorize blanket purchase order for Public Safety, Emergency Preparedness, Safety Equipment, Solutions and Related Services to Safeware, Inc., Lanham, MD in the amount not-to-exceed \$66,500.00 through December 31, 2026.

REASON FOR PURCHASE:

A national cooperative contract has been awarded through OMNIA Partners to establish a contract for Public Safety, Emergency Preparedness, Safety Equipment, Solutions and Related Services. In response to the solicitation posted by lead agency Port of Portland, four (4) proposal responses were received and evaluated by a committee. Using the evaluation criteria that was established within the RFP, the committee elected to award the contract to Safeware, Inc.

The contract offers significant cost savings, including a 41% discount off the catalog price for products and a 10% discount for services. The agreement provides access to an extensive selection of public safety and emergency preparedness products and services. The City has previously purchased safety and personal protection equipment from Safeware, Inc. and has been highly satisfied with the products and service.

It is recommended that City Council authorize the award of a blanket purchase order to Safeware, Inc.
