SUBJECT: Joint Sealant and Melter Applicators

REQUEST:

City Council is requested to authorize an increase to the blanket purchase order for joint sealant materials and melter applicators to Crafco, Inc., Chandler, AZ in the amount of \$25,000.00 for a new not-to-exceed blanket amount of \$137,680.00 through December 31, 2025.

REASON FOR PURCHASE:

The Department of Public Services uses joint sealant for the essential repair of cracks in the City's roads and pathways. Sealed bids were solicited through the MITN System, and we received one response from National Highway Maintenance Systems LTD (NHMS), a vendor that has supplied the City for several years. As of December 1, 2024, National Highway Maintenance Systems LTD was acquired by Crafco, Inc.

The Department of Public Services had more staffing available over the last two summers, enabling them to increase crack sealing work. Based on the increased usage, the remaining funds in the initial purchase order are projected to be insufficient to cover the work needed through the end of the year. Therefore, these additional funds are necessary to continue sealing critical areas of our infrastructure.
