#### Title

FY 2025 4th Quarter Budget Amendments

#### Body

**Whereas**, in accordance with the provisions of Public Act 2 of 1968, the Uniform Budgeting and Accounting Act, and the Charter for the City of Rochester Hills, Chapter III Section 3.7, the City Council may amend the budget during the fiscal year, either on its own initiative or upon recommendation of the Mayor; and

**Whereas**, the Public Hearing for the proposed FY 2025 4th Quarter Budget Amendments was noticed on November 26, 2025; and

**Whereas**, the proposed FY 2025 4th Quarter Budget Amendments were available for public viewing beginning on December 6, 2025; and
