ORDINANCE NO.

AN ORDINANCE TO AMEND SECTIONS 54-466, 54-467, 54-468, 54-469 AND 54-471 AND TO ADD 54-472 AND 54-473 AND 54-474 OF CHAPTER 54, FEES, OF THE CODE OF ORDINANCES OF THE CITY OF ROCHESTER HILLS, OAKLAND COUNTY, MICHIGAN, TO MODIFY FEES CHARGED FOR MISCELLANEOUS SERVICES, ADD EVENT PERMIT, SPORTS COURT RENTALS, AND ADD MOBILE AND TENT VENDING PERMIT FEES AND TO REPEAL CONFLICTING ORDINANCES, AND PRESCRIBE A PENALTY FOR VIOLATIONS.

THE CITY OF ROCHESTER HILLS ORDAINS:

<u>Section 1</u>. Section 54-466 of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

Sec. 54-466. Spencer Park motor vehicle entry fees.

The following schedule of motor vehicle entry fees shall apply only to Spencer Park. There shall be no charge for bicycles ridden into the park or for pedestrians. (Note: Status of residency to obtain the resident discount shall be determined by the driver's license.) Spencer Park annual permits also include entry into Bloomer Park.

- (1) Non-resident Spencer annual permit\$70.00
- (2) Resident annual permit\$35.00
- (3) Non-resident daily permit\$10.00
- (4) Resident daily permit\$5.00
- (5) Non-resident senior citizen (at least 60 years of age), <u>Mmilitary</u>, and handicap annual pass\$20.00_40.00
- (6) Resident senior citizen (at least 60 years of age), <u>Mmilitary</u> and handicap annual pass\$10.00_20.00
- (7) Annual bus rate (11 passenger or greater capacity), three times the <u>applicable</u> annual permit fee.
- (9) Non-resident off-season daily permit (day after Labor Day-May 15)\$5.00
- (10) Resident off-season daily permit\$3.00
- (11) Non-resident weekend (Saturdays and Sundays) and holidays (Memorial Day, July 4th, Labor Day) daily permit\$15.00
- (12) Resident weekend and holidays daily permit\$8.00

<u>Section 2</u>. Section 54-467 of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

Sec. 54-467. Bloomer Park motor vehicle entry fees.

The following schedule of motor vehicle entry fees shall apply to Bloomer Park. There shall be no charge for bicycles ridden into the park or for pedestrians. Annual permits shall be honored at Bloomer Park:

- (1) Bloomer only annual <u>permitpass</u>\$35.00
- (2) Bloomer daily permit\$5.00

<u>Section 3</u>. Section 54-468 of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

Sec. 54-468. Daily shelter rental.

The fees for daily shelter rental, not including motor vehicle entry fee, shall be:

Refundable Damage/Cleaning Deposit Fee that applies to all Shelter Rentals\$100.00

- (1) Stone shelter \$250.00
- (2) Pine-Grove shelter \$200.00
- (3) Hilltop shelter \$200.00
- (4) Spencer shelter \$225.00 250.00
- (5) Tent\$125.00
- (6) Innovation Hills live roof shelter full day\$250.00
- (7) Innovation Hills live roof shelter half day\$150.00
- (8) Avondale shelter full day\$100.00
- (9) Avondale shelter half day\$50.00
- (10) Veterans Memorial Pointe gazebo full day\$50.00
- (11) Veterans Memorial Pointe gazebo half day\$25.00
- (12) Borden Park Field Shelter full day\$100.00
- (13) Borden Park Field Shelter half day\$50.00

<u>Section 4</u>. Section 54-469 of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

Sec. 54-469. Commercial use of park grounds.

The fees for commercial use of park grounds shall be as follows:

- (1) One-half day (up to four hours)\$500.00
- (2) Full day (four to eight hours)\$1,000.00
- (3) Commercial photography use fee: Full-day (up to eight hours)\$100.00

<u>Section 5</u>. Section 54-471 of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

Sec. 54-471. Sports field rental.

Sports field rental<u>and lighting</u> fees are per-<u>hourgame</u>, per field, unless noted. Fees for sports fields include any motor vehicle entry fee. The field rental fees shall be as follows:

<u>Section 6</u>. Section 54-472 of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

Sec. 54-472. Event RentalsPermits or Fees.

The fees for event rentalspermit or fee are separated into three categories based on the level of staff time and materials proposed to help facilitate the event, not including motor vehicle entry fee or shelter rental, shall be:

(1) Category I (1 - 10 hours of staff time): \$100

(2) Category II (11 - 19 hours of staff time): \$250

(3) Category III (over 20 hours of staff time): \$500

<u>Section 7</u>. Section 54-473 of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

Sec. 54-473. Sports Court Rentals.

The sports court rental fees are per hour, per court. Fees for sports courts include any motor vehicle entry fee. The court rental fees shall be as follows:

(1) Resident: \$5

(2) Non-Resident: \$10

<u>Section 8</u>. Section 54-474 of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

Sec. 54-474. Mobile Vending Unit and Tent Vendors RentalsPermit.

The fees for mobile vending units and tent vendors are per day, per park. The fees shall be as follows:

(1) Mobile Vending Unit Weekday Rate: \$50

(2) Mobile Vending Unit Weekend/Holiday Rate: \$75

(3) Borden Park Tent Vendors: \$50

<u>Section 9</u>. <u>Severability</u>. This ordinance and each article, section, subsection, paragraph, subparagraph, part, provision, sentence, word and portion thereof are hereby declared to be severable, and if they or any of them are declared to be invalid or unenforceable for any reason by a court of competent jurisdiction, it is hereby provided that the remainder of this ordinance shall not be affected thereby

<u>Section 10</u>. <u>Penalty</u>. Except as otherwise provided therein, all violations of this ordinance shall be municipal civil infractions and upon a determination of responsibility therefore shall be punishable by a civil fine of \$500.

Section 11. Repeal, Effective Date, Adoption.

(1) <u>Repeal</u>. All regulatory provisions contained in other City ordinances, which are inconsistent with the provisions of this ordinance, are hereby repealed.

(2) <u>Effective Date</u>. This ordinance shall become effective on_____, 2024 following its publication in the *Oakland Press* on _____, 2024.

(3) <u>Adoption</u>. This ordinance was adopted by the City Council of the City of Rochester Hills at a meeting thereof held on ______, 2024.
