**SUBJECT:** On-Call Painting Services

#### **REQUEST:**

City Council is requested to authorize a blanket purchase order / contract to General Painting Company, LLC, 2754 York Road, Rochester Hills, MI 48309 for on-call painting services at City owned properties in the amount not-to-exceed Ninety Thousand (\$90,000) Dollars for a two-year term through August 31, 2027.

#### **REASON FOR PURCHASE:**

The City of Rochester Hills owns several buildings throughout the City that require routine maintenance and upkeep including painting services.

The City of Rochester Hills Procurement Division solicited proposals utilizing the MITN system on June 21, 2024 for on-call painting services. Ten proposal responses were received and evaluated by a committee consisting of staff from Facilities department. The proposal submitted by General Painting Company was selected as the vendor providing the best value who submitted the most responsive, responsible proposal.

General Painting Company, LLC has performed the noted services in the past in a professional and satisfactory manner.

The contract has a two-year renewal available and the vendor has agreed to hold pricing. The City wishes to exercise an option to renew with General Painting Company, LLC for a two-year term to expire on August 31, 2027.
