SUBJECT: Scope Amendment for the Gateway and Park Signage Project

REQUEST:

City Council is requested to approve an amendment to the Gateway and Park Signage Project to increase the contract for the construction and installation of the Bloomer Park sign in the amount of \$29,925.00 for a new contract amount of \$1,458,809.60 and further authorizes the Mayor to sign the amendment on behalf of the City.

REASON FOR PURCHASE:

At the June 23, 2025 meeting, the City had brought forward a Scope Amendment to defer the Bloomer Park sign due to the ongoing partnership discussions with Oakland County regarding Bloomer Park's future. Now that those discussions have been completed and a plan is formalized, the City is now ready to move forward with the fabrication and installation of the Bloomer Park Sign.

This requested contract amendment will move the City towards completion of the City's comprehensive Gateway and Park Entrance Signage Program by formally adding the Bloomer Park sign to the existing agreement with Warren Contractors. Warren Contractors has agreed to hold their contracted pricing, and fabricate and install the Bloomer Park sign. While the City has remaining funds in contingency that would cover these additional costs, the City continues to want to maintain transparency in our contracting process, and seek approval for the formal addition of this sign through a contract amendment, and utilize already budgeted FY 2026 funds for the Bloomer Park sign, which avoids depleting the project's contingency reserve in case any unknowns arise during the completion of this project and ensures the efficient completion of the signage program across the City's park system.
