REQUEST:

City Council is requested to authorize a blanket purchase order/contract for the Auburn Road & Technology Drive Traffic Signal Improvements to Rauhorn Electric, Inc., Bruce Township, Michigan in the amount of \$385,240.17 with a 10% project contingency in the amount of \$38,524.02 for a total not-to-exceed project amount of \$423,765.19 and further authorize the Procurement Manager to execute an agreement on behalf of the City.

REASON FOR PURCHASE:

The project addresses two needs; the modernization of the existing traffic signal and the replacement of the deteriorated pavement on the southbound approach of Technology Drive. The proposed design will modernize the existing box-span configuration with a new signal controller and cabinet, vehicular detection, and countdown pedestrian signals with pushbuttons. The design will also include modifications to the existing sidewalk ramps to conform with current ADA guidelines.

The Local Development Finance Authority (LDFA) is planning to cover the full expense of the project.

The City issued bids utilizing the MITN system and three (3) bids were received. Of the bids received, Rauhorn Electric, Inc. was the lowest, responsive, responsible bidder. The bid received from Rauhorn Electric, Inc. is 11% below the engineering cost estimate, which is shown on the attached bid tabulation. The City has worked with Rauhorn Electric, Inc. previously for street light repairs and has been satisfied with their services received and recommends approval of the award of the contract to them for this project.
